- 1) All quotations / tenders shall be on the basis of FOR Ballabgarh or free delivery at site in case of suppliers. All offers will be deemed to be as above unless otherwise specifically stated. Quotation tenders containing incomplete information in this regard are liable to be rejected.
- 2) The delivery period quoted shall be strictly adhered to by the suppliers. Orders not executed within validity period are liable to be cancelled automatically without reference to the suppliers
- 3) The Director General, National Council for Cement and Building Materials (NCB) Ballabgarh reserves the right to liquidated damages on the suppliers to compensate for the consequential loss the Council may be paid on account of delayed supply at stores. Such levy will amount to 0.5% of the Order value per weeks or thereof in excess of 10 days from the date of expiry of the due date of supply.
- 4) Inspection of material will be carried at our Stores (unless otherwise specifically stated in the Order). The material found to be not in conformity with the specifications / quality ordered for the rejected consequently shall be returned to the suppliers at their own cost and risk and penalty imposed as Clause 3 above.
- 5) Payment of supplier's bill will be effected only after satisfactory completion of supplies and inspection will normally be made within 30 days from the date of acceptance of materials. All payments will be made through NEFT / RTGS.
- 6) Printed terms & conditions of the suppliers will not be binding on the Council.
- 7) The Director General, National Council for Cement and Building Materials reserves the right to reject all the quotations without assigning any reason thereof.
- 8) The dispute arising between manufacturer and the purchaser will be referred to Arbitrator appointed by the Director General, NCB Ballabgarh for sole arbitration and decision there on will be binding upon both the parties i.e. manufacturer/supplier and purchaser.
- 9) No revision in rate (on higher side) will be accepted during the annual contract period.
- 10) The order will be placed as per requirement irrespective of value of the order.
- 11) The Rate Contract will be valid till 31 March 2018.
- 12) The Rate Contract can be extended for a period of three to six months on existing terms & conditions.
- 13) The firm may supply the required items as per unit price mentioned in the price list.
